T4Trade **Terms and Conditions**

T4Trade promotes its Valentine Promotion, namely This Valentine, we treat you! ("Promotion").

1. For participating in this Promotion, you have to register and be approved for a trading account based on T4Trade's Account Opening procedures and rules, as well as to be over 18 years old. All details provided during the account registration process should be correct (i.e. full name details to match the proof of identity, proof of residence to match the country of residence, etc.) otherwise the participants will not be eligible for the Promotion.
2. The Promotion is available to new Clients or existing Clients **who deposit 500 USD or more between 09 February and 16 February 2024.**
3. T4Trade employees and Partners (with the exception of Introducing Brokers) are not eligible to participate in the Promotion.
